# PROPOSED GENERAL MANDATES TO ISSUE AND BUY BACK SHARES; PROPOSED REFRESHMENT OF 2011 SHARE OPTION SCHEME MANDATE LIMIT; PROPOSED RE-ELECTION OF DIRECTORS; AND NOTICE OF ANNUAL GENERAL MEETING

#### A. INTRODUCTION

The purpose of this circular is to provide the Shareholders with information in respect of the resolutions to be proposed at the Annual General Meeting for the proposed (i) granting of the Share Issue Mandate, the Buy-back Mandate and the extension of the Share Issue Mandate; (ii) the Proposed Refreshment; and (iii) re-election of the Directors who are due to retire. This circular contains the explanatory statement in compliance with the Listing Rules and to give all the information reasonably necessary to enable the Shareholders to make an informed decision on whether to vote for or against the resolutions at the Annual General Meeting.

#### B. PROPOSED GENERAL MANDATES TO BUY BACK AND ISSUE SHARES

At the Annual General Meeting, an ordinary resolution will be proposed that the Directors be granted the Buy-back Mandate to exercise all powers of the Company to buyback Shares up to a maximum of 10% of the total number of Shares at the date of passing of the resolution approving the Buy-back Mandate.

An ordinary resolution will also be proposed at the Annual General Meeting to grant the Directors the Share Issue Mandate to allot, issue and deal with new Shares up to a maximum of 20% of the total number of Shares at the date of passing of the resolution approving the Share Issue Mandate.

As at the Latest Practicable Date, the issued share capital of the Company comprised 6,343,690,000 Shares. Assuming that there is no change in the issued share capital of the Company between the period from the Latest Practicable Date and the date of passing the resolution approving the Share Issue Mandate, the maximum number of Shares which may be issued pursuant to the Share Issue Mandate on the date of passing the resolution approving the Share Issue Mandate will be 1,268,738,000 Shares.

If the Buy-back Mandate and the Share Issue Mandate are approved to be granted at the Annual General Meeting, an ordinary resolution will be proposed at the Annual General Meeting to authorise that any Shares repurchased under the Buy-back Mandate will be added to the total number of new Shares which may be allotted and issued under the Share Issue Mandate.

The Buy-back Mandate, the Share Issue Mandate and the extension of the Share Issue Mandate will, if granted, remain in effect until the earliest of (i) the conclusion of the next annual general meeting of the Company; or (ii) the expiration of the period within which the next annual general meeting of the Company is required by any applicable law or the Bye-laws of the Company to be held; or (iii) the date on which the authority given to the Directors by the resolution concerned is revoked or varied by an ordinary resolution of the Shareholders in general meeting.

An explanatory statement as required by the Listing Rules to provide all relevant information relating to the proposed Buy-back Mandate is set out in Appendix I to this circular. The information in the explanatory statement is provided to you with information reasonably necessary to enable you to make an informed decision on whether to vote for or against the resolution to grant to the Directors the Buy-back Mandate.

#### C. REFRESHMENT OF THE SCHEME MANDATE LIMIT

The Company adopted the 2011 Share Option Scheme pursuant to a resolution passed on 9 August 2011. Apart from the 2011 Share Option Scheme, the Company has no other share option scheme currently in force.

The purpose of the 2011 Share Option Scheme is to enable the Company to grant Options to the Eligible Participants in recognition of their contribution to the Group.

## **Share Option Scheme**

Pursuant to the 2011 Share Option Scheme, the total number of Shares which may be issued upon exercise of all Options to be granted by the Company under the 2011 Share Option Scheme and any other options to be granted by the Company under any other share option schemes of the Company must not in aggregate exceed 10% of the shares of the Company in issue as at the date of approval of the 2011 Share Option Scheme or as at the date of approving the refreshment of Scheme Mandate Limit. With the approval of the Shareholders in general meeting, the Board may refresh the 10% limit under the 2011 Share Option Scheme. Options previously granted under the 2011 Share Option Scheme (including those outstanding, cancelled and lapsed or exercised options) will not be counted for the purpose of calculating the limit as "refreshed". However, the total number of shares of the Company which may be issued upon exercise of all outstanding Options granted and yet to be exercised under the 2011 Share Option Scheme and all outstanding options granted and yet to be exercised under any other scheme shall not exceed 30% of the shares of the Company in issue from time to time.

According to the Scheme Mandate Limit being refreshed pursuant to the ordinary resolution passed by the Shareholders at the annual general meeting held on 7 September 2016 ("Approval Date"), the Company is allowed to grant Options entitling holders to subscribe for up to 534,369,000 Shares. As at the Latest Practicable Date, 379,500,000 Options (of which no option was exercised, lapsed and cancelled) were granted under the Scheme Mandate Limit as granted at the Approval Date.

As at the Latest Practicable Date, a total of 6,343,690,000 Shares were in issue. There are in aggregate 497,220,000 options granted and remained outstanding under the 2002 Share Option Scheme and the 2011 Share Option Scheme, which entitling the holders of the options to subscribe for an aggregate of 497,220,000 Shares representing approximately 7.84% of the issued share capital of the Company. Since adoption of the 2011 Share Option Scheme on 9 August 2011, total 571,000,000 Options were granted (of which 40,000,000 were exercised and 36,200,000 Options were lapsed and cancelled) and 494,800,000 Options are remained outstanding. Since the Approval Date, total 1,080,000 options were lapsed and cancelled and there are 2,420,000 options remained outstanding under 2002 Share Option Scheme.

In view of the existing 10% Scheme Mandate Limit has almost utilised in full, the refreshment of the Scheme Mandate Limit will provide more flexibility to the Company to provide incentives and rewards to the Eligible Participants for their contribution or potential contribution to the Group. The Directors consider that the refreshment of the Scheme Mandate Limit is in the interests of the Company and the Shareholders as a whole.

Assuming that there is no change in the issued share capital of the Company between the period from the Latest Practicable Date and the date of the Annual General Meeting and that no further Options will be granted under the 2011 Share Option Scheme prior to the date of the Annual General Meeting, the number of Shares that may fall to be allotted and issued upon exercise in full of the options that may be granted, after the relevant resolution is passed at the Annual General Meeting, would be 634,369,000 Shares, which representing 10% of the issue share capital of the Company.

The refreshment of the Scheme Mandate Limit is conditional upon:

- 1. the passing by the Shareholders of an ordinary resolution at the Annual General Meeting to approve, among other things, the refreshment of the Scheme Mandate Limit; and
- 2. the Listing Committee of the Stock Exchange granting the listing of, and permission to deal in, 10% of the Shares in issue at the date of approval of the refreshment of the Scheme Mandate Limit which may be issued pursuant to the exercise of Options to be granted under the 2011 Share Option Scheme.

Application will be made to the Listing Committee of the Stock Exchange for the grant of listing of, and permission to deal in, 10% of the Shares in issue at the date of approval of the refreshment of the Scheme Mandate Limit which may be issued pursuant to the exercise of Options to be granted under the 2011 Share Option Scheme.

# D. PROPOSED RE-ELECTION OF DIRECTORS

In accordance with Bye-laws 87(1) and 86(2), Mr. Zhang Xianlin, Mr. Kwok Hong Yee, Jesse, Mr. Ng Ping Yiu, Mr. Liu Yan Chee, James, Mr. Chan Yuk Sang and Mr. Li Yuguo will retire at the Annual General Meeting, and, being eligible, offer themselves for re-election as Directors at the Annual General Meeting.

Mr. Zhang Xianlin, Mr. Kwok Hong Yee, Jesse and Mr. Ng Ping Yiu, being independent non-executive Directors eligible for re-election at the Annual General Meeting, have provided their annual written confirmations of independence pursuant to Rule 3.13 of the Listing Rules. The Company is of the view that Mr. Zhang Xianlin, Mr. Kwok Hong Yee, Jesse and Mr. Ng Ping Yiu meet the independence guidelines set out in Rule 3.13 of the Listing Rules and are regarded as independent in accordance with the terms of the guidelines.

Set out below are the biographical details of Mr. Zhang Xianlin, Mr. Kwok Hong Yee, Jesse, Mr. Ng Ping Yiu, Mr. Liu Yan Chee, James, Mr. Chan Yuk Sang and Mr. Li Yuguo:

#### (A) Mr. Zhang Xianlin ("Mr. Zhang"), an independent non-executive Director

Mr. Zhang Xianlin, aged 63, was appointed as an independent non-executive director of the Company on 16 December 2008. Mr. Zhang is also the chairman of Remuneration Committee, and members of each of Audit Committee and Nomination Committee of the Company. Currently, Mr. Zhang is the director of Chinese Fund Investment Management Limited. Mr. Zhang graduated from Huazhong University of Science and Technology with a Master Degree in Business Administration and a Doctor Degree in Management. He is a Chinese certified public accountant and senior accountant. During the period from 1974 to 2007, he served in the senior management positions in China National Aviation Corporation (Group) Limited and the Civil Aviation Administration of China. Besides, Mr. Zhang was a general manager in China National Aviation Company Limited, an executive director in Hong Kong Dragon Airlines Limited, the chairman of the Board of Supervisors in Air Macau Company Limited and the chairman of the Board of Supervisors in Air China Limited (stock code: 753), a company listed on The Stock Exchange of Hong Kong.

Mr. Zhang was also a non-executive director of Cathy Pacific Airways Limited (stock code: 293), a company listed on The Stock Exchange of Hong Kong, during the period from August 1997 to May 2005. Mr. Zhang has over 35 years of extensive experience in enterprise finance and investment management.

A letter of appointment has been entered into between the Company and Mr. Zhang. He is appointed for a term of three years and subject to retirement and re-election in accordance with the Bye-laws. Mr. Zhang is entitled to a monthly director's fee of HK\$13,000 which is recommended by the Remuneration Committee and determined by the Board with reference to his duties and responsibilities and the prevailing market conditions.

Save as disclosed above, as at the Latest Practicable Date, Mr. Zhang does not (i) hold any other position with the Company or its subsidiaries; (ii) hold any other directorships in any other public companies, the securities of which are listed on any securities market in Hong Kong or overseas in the last three years; and (iii) have any relationship with any other Directors, senior management or substantial or controlling shareholders of the Company (as defined in the Listing Rules).

As at the Latest Practicable Date, within the meaning of Part XV of the SFO, Mr. Zhang has 6,840,000 underlying Shares attached to the share options granted by the Company, represent 0.11% of the existing issued share capital of the Company.

Save as disclosed above, Mr. Zhang did not have any interest in the shares or underlying shares of the Company within the meaning of Part XV of the SFO.

# (B) Mr. Kwok Hong Yee, Jesse ("Mr. Kwok"), an independent non-executive Director

Mr. Kwok Hong Yee, Jesse, aged 64, was appointed as an independent non-executive director of the Company on 8 November 2011. Mr. Kwok is also the chairman of the Nomination Committee, and members of each of the Audit Committee and Remuneration Committee of the Company. Mr. Kwok is a solicitor and notary public and is the sole proprietor of Messrs. Jesse H.Y. Kwok & Co. with substantial previous working experiences acting as solicitor of the Supreme Court of Hong Kong. He obtained his degrees of Bachelor of Laws (LLB) and Master of Laws (LLM) in Civil Laws from the Peking University in the People's Republic of China. Mr. Kwok was appointed as a Temporary Magistrate between December 1994 and March 1995, and a Temporary Adjudicator of the Small Claims Tribunal in July 1998. He is also a Panel Arbitrator. He is also a member of the Law Society of Hong Kong, the Law Society of United Kingdom, Singapore Academy of Law and is the Counsel Member of the Hong Kong Society of Notaries. Mr. Kwok is also a China Appointed Attesting Officer.

Mr. Kwok was an independent non-executive director of China Infrastructure Investment Limited (stock code: 600), a company listed on The Stock Exchange of Hong Kong Limited, during the period from August 2005 to August 2012.

A letter of appointment has been entered into between the Company and Mr. Kwok. He is appointed for a term of three years and subject to retirement and re-election in accordance with the Bye-laws. Mr. Kwok is entitled to a monthly director's fee of HK\$13,000 which is recommended by the Remuneration Committee and determined by the Board with reference to his duties and responsibilities and the prevailing market conditions.

Save as disclosed above, as at the Latest Practicable Date, Mr. Kwok does not (i) hold any other position with the Company or its subsidiaries; (ii) hold any other directorships in any other public companies, the securities of which are listed on any securities market in Hong Kong or overseas in the last three years; and (iii) have any relationship with any other Directors, senior management or substantial or controlling shareholders of the Company (as defined in the Listing Rules).

As at the Latest Practicable Date, within the meaning of Part XV of the SFO, Mr. Kwok has 6,700,000 underlying Shares attached to the share options granted by the Company, represent 0.11% of the existing issued share capital of the Company.

Save as disclosed above, Mr. Kwok did not have any interest in the shares or underlying shares of the Company within the meaning of Part XV of the SFO.

Save as disclosed above, there is no information to be disclosed pursuant to Rule 13.51(2)(h) to (v) of the Listing Rules nor are there any other matters that need to be brought to the attention of the Shareholders in connection with the re-election of Mr. Kwok.

#### (C) Mr. Ng Ping Yiu ("Mr. Ng"), an independent non-executive Director

Mr. Ng Ping Yiu, aged 50, was appointed as an independent non-executive director, the chairman of the Audit Committee, and members of each of the Nomination Committee and Remuneration Committee of the Company on 1 October 2016. He holds a Master of Business Administration degree from the University of Heriott Watt of United Kingdom and is a fellow of the Hong Kong Institute of Certified Public Accountants, a fellow of the Association of Chartered Certified Accountants, a member of the Hong Kong Institute of Chartered Secretaries, a member of Institute of Chartered Secretaries and Administrators and also a fellow of the Taxation Institute of Hong Kong. He is also a certified tax adviser in Hong Kong.

Mr. Ng is currently the principal of GDT CPA Limited. He served as tax manager and senior tax manager of international accounting firms in Hong Kong for over 10 years. He has substantial working experience in Hong Kong, the PRC and international tax, corporate structuring, planning advisory services and accounting services and specializes in providing advices on PRC corporate and individual income taxes, VAT, customs duty, transfer pricing, and other regulatory or practical issues normally encountered by Hong Kong manufacturers with production and distribution operations in the PRC, and by foreign investors planning and setting up operations in the PRC. He also holds qualification to practice PRC Tax in Qianhai, Shenzhen, the PRC.

A letter of appointment has been entered into between the Company and Mr. Ng. He is appointed for a term of three years and subject to retirement and re-election in accordance with the Bye-laws. He is entitled to a monthly director's fee of HK\$13,000 which is recommended by the Remuneration Committee of the Company and determined by the Board with reference to his duties and responsibilities and the prevailing market conditions.

In February 1994, he graduated from Dalhousie University in Canada with a Bachelor of Commerce. Mr. Liu is an independent non-executive director of Luen Wong Group Holdings Limited (Stock Code: 8217).

A letter of appointment has been entered into between the Company and Mr. Liu. He is not appointed for a specific term except that he is subject to retirement and re-election in accordance with the Bye-laws. He is entitled to a monthly director's fee of HK\$32,000 which is recommended by the Remuneration Committee and determined by the Board with reference to his duties and responsibilities and the prevailing market conditions.

As at the Latest Practicable Date, Mr. Liu is also a director of the subsidiaries of the Company, namely World Metro Investment Limited, Global Fair Trading Limited, Global Asia Enterprises Limited, Asiaciti Investment Limited, East Dynasty Group Limited, World Legend Enterprises Limited and World Land Development Limited.

#### (E) Mr. Chan Yuk Sang ("Mr. Chan"), an executive Director

Mr. Chan, aged 71, was appointed as an executive director of the Company on 28 April 2017. He has more than 30 years of experience in the banking and finance industry. He was the chairman of Century Legend (Holdings) Limited (Stock Code: 79) from September 1999 to July 2002 and a director of Hong Kong Building & Loan Agency Limited (Stock Code: 145) from 1993 to 1995, an independent non-executive director of Opes Asia Development Ltd (Stock Code: 810) from April 2011 to June 2012, an independent non-executive director of GOME Electrical Appliances Holding Ltd (Stock Code: 493) since May 2004 to June 2015, an independent non-executive director of Imagi International Holdings Limited (Stock Code: 585) since May 2010 to January 2016. Mr. Chan is currently an independent non-executive director of Four Seas Mercantile Holdings Limited (Stock Code: 374). All of these six companies are listed on the Stock Exchange. He was a senior general manager of a local bank and an executive director of a joint Chinese foreign bank in Shenzhen.

A letter of appointment has been entered into between the Company and Mr. Chan. He is not appointed for a specific term except that he is subject to retirement and re-election in accordance with the Bye-laws. As at the Latest Practicable Date, Mr. Chan is also a director of the subsidiary of the Company, namely World Metro Investment Limited.

Save as disclosed above, as at the Latest Practicable Date, Mr. Chan does not (i) hold any other position with the Company or its subsidiaries; (ii) hold any other directorships in any other public companies, the securities of which are listed on any securities market in Hong Kong or overseas in the last three years; and (iii) have any relationship with any other Directors, senior management or substantial or controlling shareholders of the Company (as defined in the Listing Rules).

Save as disclosed above, Mr. Chan did not have any interest in the shares or underlying shares of the Company within the meaning of Part XV of the SFO.

Save as disclosed above, there is no information to be disclosed pursuant to Rule 13.51(2)(h) to (v) of the Listing Rules nor are there any other matters that need to be brought to the attention of the shareholders of the Company in connection with the re-election of Mr. Chan.

#### (F) Mr. Li Yuguo ("Mr. Li"), an executive Director

Mr. Li, aged 63, was appointed as an executive director of the Company on 16 August 2017. He has been a non-executive director of Shengjing Bank Co., Ltd. (盛京銀行股份有限公司), a company listed on the Main Board of The Stock Exchange of Hong Kong Limited (Stock Code: 2066), since July 2013 and the vice chairman of the board of directors of the said bank since June 2014. He has been the chairman of Liaoning Huibao International Investment Group Co., Ltd. since June 2013 and the chairman of Beijing Jiutai Group Co., Ltd. (北京九台集團有限公司) since May 1993. Prior to that, he successively worked at the planning bureau of the China Association for Science and Technology (中國科學技術協會) as principal staff, deputy chief and chief of the accounting division from August 1983 to October 1992.

Mr. Li graduated from Jiangxi University of Finance and Economics (formerly known as Jiangxi Institute of Finance and Economics (江西財經學院)) (Jiangxi, PRC) in July 1983, majoring in industrial accounting.

A letter of appointment has been entered into between the Company and Mr. Li. He is not appointed for a specific term except that he is subject to retirement and re-election in accordance with the Bye-laws. He is entitled to a monthly director's fee of HK\$32,000 which is recommended by the Remuneration Committee and determined by the Board with reference to his duties and responsibilities and the prevailing market conditions.

As at the Latest Practicable Date, Mr. Li holds 1,000,000,000 shares in the Company, representing approximately 15.8% of the entire issued share capital of the Company. Mr. Li is also the 80% shareholder of Hong Kong Spring Water Ding Dong Group Company Limited ("HK Spring Water"), a company which the Company currently holds 20% shareholding interest. Mr. Li is also a director of HK Spring Water.

Save as disclosed above, as at the Latest Practicable Date, Mr. Li does not (i) hold any other position with the Company or its subsidiaries; (ii) hold any other directorships in any other public companies, the securities of which are listed on any securities market in Hong Kong or overseas in the last three years; and (iii) have any relationship with any other directors, senior management or substantial or controlling shareholders of the Company (as defined in the Listing Rules).

Save as disclosed above, Mr. Li did not have any interest in the shares or underlying shares of the Company within the meaning of Part XV of the SFO.

Save as disclosed above, there is no other information to be disclosed pursuant to Rules 13.51(2)(h) to (v) of the Listing Rules nor are there any other matters that need to be brought to the attention of the shareholders of the Company in connection with the re-election of Mr. Li.

#### H. RECOMMENDATIONS

This Appendix serves as an explanatory statement given to all the Shareholders, as required by the Listing Rules, to provide requisite information of the Buy-back Mandate.

#### 1. LISTING RULES FOR BUY-BACK OF SHARES

The Listing Rules permit companies whose primary listing is on the Stock Exchange to buy back their fully-paid shares subject to certain restrictions, the more important of which are summarised below:

#### (a) Share capital

Under the Buy-back Mandate, the number of Shares that the Company may buyback shall not exceed 10% of the aggregate nominal amount of the issued share capital of the Company at the date of the passing of the relevant resolution granting the Buy-back Mandate. The Company's authority is restricted to purchase in accordance with the Listing Rules. As at the Latest Practicable Date, there were in issue an aggregate of 6,343,690,000 Shares. Exercise in full of the Buy-back Mandate, on the basis that no further Shares would be issued or repurchased prior to the date of the Annual General Meeting, would accordingly result in up to 634,369,000 Shares being repurchased by the Company. The Shares repurchased by the Company shall, subject to applicable law, be automatically cancelled upon such buy-back.

#### (b) Reasons for buy-back

The Directors have no present intention to buyback any Shares but consider that the Buy-back Mandate will provide the Company the flexibility to make such buy-back when appropriate and is beneficial to the Company. Such buy-back may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and/or its earnings per Share. As compared with the financial position of the Company as at 31 March 2017 (being the date of its latest audited accounts), the Directors consider that there would not be any material adverse impact on the working capital and on the gearing position of the Company in the event that the Buy-back Mandate is exercised in full at any time during the proposed buy-back period. In the circumstances, the Directors do not propose to exercise the Buy-back Mandate to such an extent that would have a material adverse impact on the working capital or gearing ratio of the Company.

#### (c) Funding of buy-back

Buy-back of the Shares will be funded out of funds legally available for such purpose in accordance with the memorandum of association of the Company and Bye-laws and the applicable laws of Bermuda.

#### (d) Directors, their close associates and connected persons

None of the Directors nor, to the best of the knowledge and belief of the Directors having made all reasonable enquiries, any of their close associates has any present intention, in the event that the proposed Buy-back Mandate is approved by the Shareholders, to sell Shares to the Company.

As at the Latest Practicable Date, no core connected person (as defined in the Listing Rules) of the Company has notified the Company that he/she has a present intention to sell Shares to the Company nor has he/she undertaken not to sell any of the Shares held by him/her to the Company in the event that the Buy-back Mandate is granted.

#### (e) Undertaking of the Directors

The Directors have undertaken to the Stock Exchange that they will exercise the powers of the Company to make buy-back pursuant to the Buy-back Mandate in the proposed resolution in accordance with the Listing Rules and the applicable laws of Bermuda.

#### (f) Effect of the Takeovers Code

If as a result of a buy-back of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of Rule 32 of the Takeovers Code. As a result, a Shareholder, or a group of Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase in the Shareholder's interests, could obtain or consolidate control of the Company and become(s) obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.
